The following resolutions were taken in the meeting:

Agenda 1: Confirmation of previous meeting held on dated 25-09-2018

Members of IQAC confirmed the minutes of meeting held on 25-09-2018.

Agenda 2: Analysis of previous meeting held on dated 25-09-2018

Members of IQAC discussed in detail and suggested positively over all the issues of previous past agendas such as M.O.U with nearby institutions and colleges, Alumni Association, leased line for high speed internet facilities, towards the formation of a committee of some senior teachers along with head assistant for development of central library, workshop/seminar on Intellectual Property Right (IPR), efforts to promote research culture, fund mobilization, teacher-parents meet, counseling cell, feedback from all stake-holders etc. From the previous agendas like formation of Alumni Association and the formation of a library development committee have been done this year. Intellectual based seminars/workshop (from the department of Philosophy, NSS and NCC) take place time to time in the college. Simultaneously, on the remaining agendas work are in progress. Additionally, members also discussed over the expansion of more UG (Diploma and certificate) courses, in the college. On the discussion over to run the awareness program in the nearby villages on Vermi-compost, anti-dowry campaign etc., Dr. Shashi Kumar has suggested that to conduct seminar/workshop in the college campus time to time rather than to go door to door at the nearby villages. On the issue of less number of permanent faculty members in various departments, members suggested to wait for appointment by the university, although guest faculties run the departments in which there are not permanent faculty members.

Agenda 3: Discussion over the improvement of seminar hall (Room no. B-18/ A-8).

Members of IQAC discussed in detail and finally unanimously passed room no A-8 as the seminar hall in the college. Simultaneously, for the improvement of seminar hall the requirements such as a complete audio-video system, proper arrangement of lights, chairs, projector, screen, fans as well as Air-Conditioning of the room and a good platform in front of the audience were passed.

Agenda 4: Discussion over the development of central Library (for fully automation, E-library, reading-space).

Members of IQAC discussed in detail for central library and unanimously suggested there are needs of more reading space students as well as for teachers. Further, they suggested for a separate e-library room with attached full facilities. Additionally, on the fully automation of central library members of IQAC were also discussed. To fulfill the fully automation of central library, Dr. Arun Kumar, (Coordinator IQAC, Patliputra University, Patna and member of IQAC of the college) suggested for the training program of two persons from INFLIBNET, Gandhinagar. He also suggested to involve for "Earn while learn" practices for those students who are currently doing B.LIS. from the college. And these suggestions of Dr. Arun Kumar have been passed unanimously by IQAC members of the college.

Agenda 5: Plantation and beautification of the college campus.

Unanimously, members of IQAC suggested for proper plantation and nurturing trees/plants time to time in the college campus. In the four quadrant of the college (the area which is divided into four quadrants in front of office or departments) there should be fencing and plantation of seasonal flowers in all.

Agenda 6: Others if any:

Miss. Pooja Kumari a member of IQAC from student representative asked for improvement of sanitation of girl's wash room and requirement of adequate drinking water for students in the college campus. Simultaneously, Dr. Md. Shamim Alam asked for the supply of proper electricity in the college campus to fulfill the requirement of voltage fluctuation especially for the laboratories. Unanimously, members of IQAC agreed for the said requirements.
